

## **Santa Barbara Botanic Garden**

### **Professional Photography Agreement**

A one-day Special Occasion Photography Permit (e.g. personal, family, wedding, or anniversary) is issued on a first-come-first serve basis and may be obtained Monday through Friday, 9:00 a.m. to 3:00 p.m. from the Visitors Services Representative in the Kiosk or Brittney Burrows, Development Associate for events. (805-682-4726 ext. 103)

- A. The nonrefundable fee—due upon granting of permit—is \$100 for a maximum of 2 hours. If additional time is granted it is an additional \$50 per hour.
- B. The photographic party is limited to 15 people maximum, photographers included.
- C. Photography session must occur within regular Garden hours: March – October, 9:00 a.m. to 6:00 p.m.; November - February, 9:00 a.m. to 5:00 p.m.
- D. Each session is limited to 120 minutes or 2 hours. Additional time may be granted in advance of session with authorized Garden approval only. Additional time must not go beyond Garden hours.
- E. Guidelines:
  - 1. Party must arrive at the reserved time and will be greeted by a Visitors Services Representative.
  - 2. Permit fee includes admission for up to 15 people, photographers included. (Additional individuals must pay regular admission fees).
  - 3. Pathways may not be obstructed by the photographer or members of the party so as to impede visitor traffic.
  - 4. Party must remain on pathways only. Photography is not permitted in exhibit areas, on rocks, etc. Party will be billed accordingly for any damage to plants or Garden property.
  - 5. Nudity is not permitted in the Garden.
- 5. The Garden reserves the right to refuse photographic privileges to anyone or to rescind privileges if guidelines are not followed or it is deemed unsafe conditions.
